FACILITY USE CRITERIA

1. **FACILITY USE CRITERIA - Equestrian Park**
 - a. **BEFORE UNLOADING ANIMALS FROM TRAILERS** – Owner must notify Fairgrounds if any animal is ill or under a veterinary's care.
 - b. Stalls must be bedded before animals are stabled.
 - c. Animals are to remain in assigned stalls or pens while on the Fairgrounds.
 - d. Once occupied, stalls are not to be locked - outdoor cattle pens are lockable (per Snohomish County Fire Code).
 - e. Unless approved in advance, animals are not allowed in any of the exercise rings or arenas.
 - f. Individuals are not allowed to sleep in barns and stalls (per Snohomish County Fire Code).
 - g. Dogs are not allowed inside the barn unless approved otherwise by Fairgrounds Management.
 - h. The Fairgrounds does not assume any security responsibility.
2. **OWNER'S RESPONSIBILITY INCLUDES:**
 - a. Daily care of animals (water is available on the grounds; owner is responsible for providing own feed).
 - b. Keep stalls clean and final cleaning prior to moving out - check in with Fairgrounds maintenance or Office before leaving grounds.
 - c. Used shavings are to be hauled to the waste bunker.
3. **TEMPORARY EMERGENCY ACCOMMODATIONS (5 days or less):**
 - a. Emergency stabling is provided at no charge only during those emergencies that the Snohomish County Dept of Emergency Management (DEM) deems this service is warranted and only on a temporary basis.
 - b. While available, bedding will be at no charge.

WAIVER AND RELEASE FROM LIABILITY

IN CONSIDERATION for being permitted to enter Snohomish County Property, The Undersigned on behalf of themselves and their estate, hereby waives any right of recovery and releases Snohomish County, their officers, officials, employees and agents, from any liability related to any injury suffered by the Undersigned, and further the Undersigned agrees and undertakes to indemnify, hold harmless and defend the County from and against any and all claims, damages, actions, liability and expenses including attorney's fees and other professional fees in connection with bodily injury including death and personal injury by the UNDERSIGNED's employees or third party

The Undersigned further acknowledges and agrees that the County does not assume any responsibility whatsoever for any property of the Undersigned and the Undersigned shall not hold the County liable for any loss or damages to same.
